Memorial Hall, Corryong, Victoria
Starts Good Friday 2nd April at 10am to 4pm, 11th April 2010

1. PRESENTATION: All pieces must have "ARTIST NAME" and "TITLE" on the back. A strong hanging wire or cord must be fixed securely (suggest flat hanging rings, not screw eyes) to each side of the frame - please allow some slack.
2. EXHIBITS: Any number of exhibits is acceptable. All work must be for sale and exhibits may have had one previous showing here, but no more. As always, we reserve the right not to display work that we consider unsuitable.
PLEASE LIST YOUR WORKS IN PRIORITY ORDER in case exhibit numbers need to be limited. If a piece of your work is not then displayed, entry money will be refunded.
3. CATEGORIES: Exhibits will be received in each of the four categories below - please give details:
 - a. PHOTOGRAPHY (mono/colour, traditional/inkjet)
 - b. OIL/ACRYLIC
 - c. WORKS ON PAPER (watercolour/pastel/drawing)
 - d. OTHER MEDIA (SCULPTURE/WOOD/POTTERY)
4. COMPETITIONS: To competitions are offered:
 - (a) External judging: Categories 1-3 only. Cash prize of \$500 to winning entry in each.
 - (b) Viewer Choice Competition: All exhibits in categories 1-4 above are eligible to receive votes. Prizes artists and voters.
5. PRIZE-MONEY: Will be sent via EFT the week following the Festival. Please provide EFT details on entry section of this form.
6. CATALOGUE LISTINGS: Except for multiple items, each exhibit must be listed separately on this form and will be given an individual catalogue number.
7. EXHIBIT FEES:
 - (a) Single items of value \$30 or more: \$6 each for the first 5 items and \$3 each thereafter
 - (b) Multiple items of the same value, such as "Cards": one exhibit fee.
 - (c) Single items less than \$30: no fee
8. PROMOTIONAL: We, and the viewers, greatly appreciate information about you/your work. Please submit, for a display folder, up to two A4 sheets of such information (including, if desired, contact details for interested viewers).
8. GROUPING OF WORK: Generally we will group artists work together.
9. GST AND TAX INVOICES for GST registered Artists.
As the agent of a GST registered artist the Festival Committee has the artist's authority to provide a tax invoice to the buyer, if such invoice is requested.
10. FESTIVAL COMMISSION: 22% on all work sold.
11. DELIVERY: Artwork may be sent direct to the Festival Office with any transport costs (both ways) met by the artist. It may also be delivered personally to the Exhibition venue on Wed 31st March to minimize handling. If you prefer, for a single surcharge of \$5 per exhibit (max charge \$15) we will collect/return your work to one of the designated collection points.
12. PACKAGING: It is quite possible to successfully post fully framed art work from anywhere in Australia but in this case a third party who handles your work may not understand the need to be careful. Pack seriously and thoroughly if posting work, remembering that packaging must be reusable. PLEASE POST EXHIBIT FORMS, CHEQUES AND ARTIST INFORMATION SEPARATELY TO ART WORK as these are required prior to unpacking your work.

13. **ARTWORK SIZE:** Very large art pieces can certainly add to an exhibition but transport, handling and display is more complex. Please limit the number of large pieces and if exhibiting, pack very robustly.

14. **REQUIRED FOR YOUR ENTRY:** Please complete all sections of the exhibit form (including Tax Status declaration) and sign where required. Where possible EFT entry fees to the Festival account (details below) or make cheques payable to "MAN FROM SNOWY RIVER BUSH FESTIVAL". Post exhibit form, fees and A4 information to:
